### Ashleigh M. Rollins



Ms. Rollins is an experienced school law attorney who has had the pleasure of serving school districts with a range of matters including labor and employment, student issues, special education, governance and charter petitions. She feels very fortunate to practice education law and to work alongside conscientious administrators who have the best interests of students at heart.

### Liz A. Harland

Prior to joining Adams Silva & McNally, Ms. Harland served as a legal intern at the University of San Diego Education & Disability Clinic, where she represented low-income parents of students with disabilities in cases ranging from special education to limited conservatorships. Ms. Harland interned with the San Diego Volunteer Lawyer Program's Family Law Project, where she appeared in family court on behalf of domestic violence victims and received the organization's Distinguished Service Award. As a law clerk with the General Counsel of the San Diego County Regional Airport Authority, she assisted in the representation of its Board, executive staff, and its several divisions and departments on matters ranging from governance to employment disputes.



Prior to attending law school, Ms. Harland volunteered with the American Indian Recruitment Program, where she prepared statistically disadvantaged American Indian high school students for success in higher education. Additionally, Ms. Harland served as the President of the Pre-Law Society at San Diego State University. Ms. Harland earned her Juris Doctor at the University of San Diego School of Law. While there, she served on the Moot Court Executive Board, where she competed in a national moot court tournament hosted in Washington D.C. Ms. Harland has been published in the 2015 issue of the San Diego Journal of Climate and Energy Law.

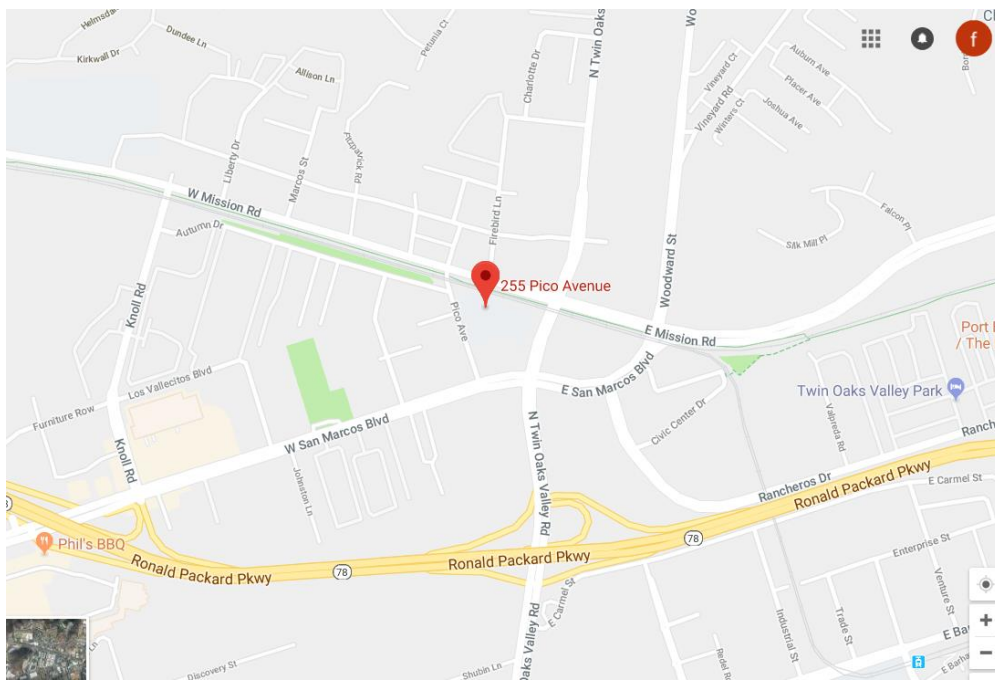
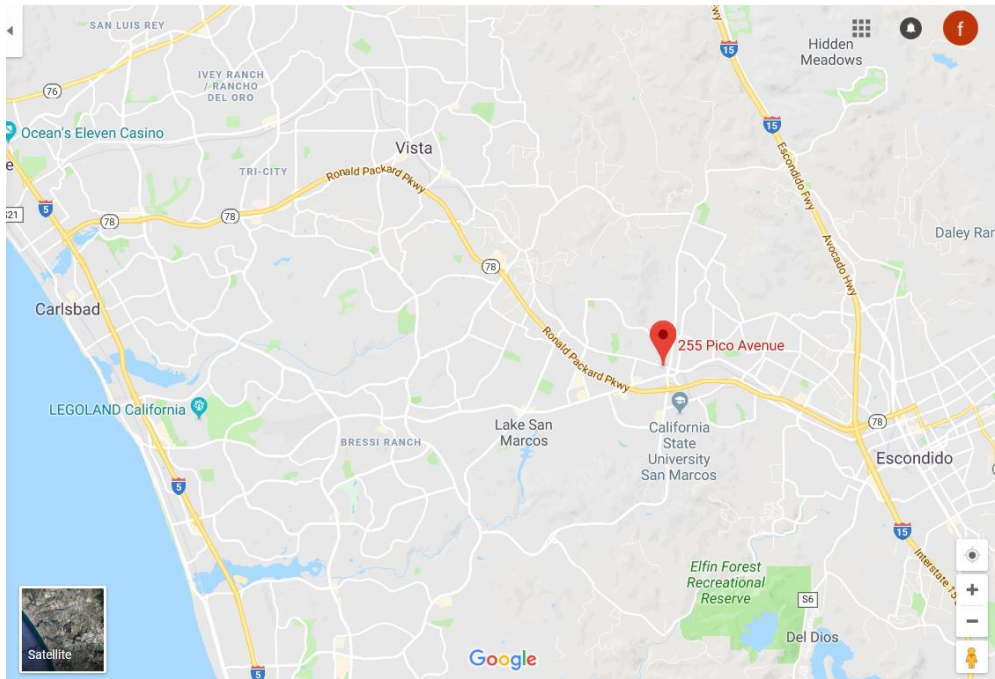
