

Delta Sierra Attendance Certification Program Sherman Garnett, Presenter



It was a day of laughter and learning at Quincy Jr./Sr. High during the Attendance Certification Training sponsored by CASCWA Delta-Sierra Section and the Plumas County Office of Education. The day-long training was hosted by two longtime CASCWA members, Sherman Garnett of Garnett & Associates and National Education Manager, Erica Peterson, of School Innovations & Achievement. The training was part of Plumas County's agency wide "Welcome Back" professional development day. Attended by site and district personnel, the training covered an array of attendance topics including: updated attendance laws, enrollment and disenrollment procedures, and communication skills training for handling upset parents.

Attendees were provided a binder of tools from Garnett to use that included sample SARB pamphlets in Spanish and English, parent communication samples, and a sample Independent Study contract. Garnett, a student services veteran, challenged attendees, testing their knowledge with a quiz using real-life absence scenarios and posing a simple question at the end of each scenario, "Is this an excused or unexcused absence?" A theme emerged as participants could be heard throughout stating, "I didn't know that" as Garnett moved through his curriculum.

Peterson wrapped the training by teaching attendees SI&A's "ABCs of Parent Communication" a technique to diffuse confrontations that can sometimes arise when discussing attendance



concerns. Giggles were heard across the room as participants role-played being unruly parents and using the ABC strategy to handle those tense moments.

The training in Plumas county marks the third Attendance Certification hosted by Delta-Sierra. Additional trainings are slated in Shasta and Sutter counties in early 2020. Chronic absenteeism: Thurmond said the issue has been important to him dating back to his previous career as a social worker in the Bay Area, when he noticed that asthma is a big reason for children missing school.

"I spent a lot of time doing outreach to families where kids were chronically absent. Sometimes kids were sick. I suspect there may be other health illness issues with young children. Sometimes there are children taking care of younger children. Family members depend on them," he said. And he said there are other challenges: poverty, homelessness, trauma in the family and transportation.

"There's nothing like human contact with the family to figure out what their barrier is," he said. He said he'd like to see the state help districts with parental support. "I know (districts) need funding for that because most cut their outreach staff long ago when the budgets were really tight."

Attendance Awareness and Model Attendance Programs

I am writing today to urge you to join me in the annual Attendance Awareness Campaign and to consider developing a model school attendance program this year to ensure more of California's school children have an opportunity to succeed.

One of my highest priorities as State Superintendent of Public Instruction is to lead the effort to reduce California's unacceptably high chronic absenteeism rates starting with early learning and care programs and upward into K-12. Chronic absenteeism is a crisis in California's early learning and public education system, dropping the achievement rates of one out of four students in some student groups. Even with the best teachers, best curriculum, and best facilities, children and students will not learn if they are missing too much school. A significant number of chronic absentee children and students are from racial ethnic subgroups: African American, American Indian or Alaska Native, or Pacific Islander. Other chronic absentees are foster youth, homeless youth, students with disabilities, and our youngest learners.

Now is the right time to plan a messaging campaign to parents, guardians, and caregivers to let them know how critical good attendance is to the success of their children, especially in the early years when children are building a foundation for learning to read proficiently.

One of my highest priorities as State Superintendent of Public Instruction is to lead the effort to reduce California's unacceptably high chronic absenteeism rates starting with early learning and care programs and upward into K-12. Chronic absenteeism is a crisis in California's early learning and public education system, dropping the achievement rates of one out of four students in some student groups. Even with the best teachers, best curriculum, and best facilities, children and students will not learn if they are missing too much school. Other chronic absentees are foster youth, homeless youth, students with disabilities, and our youngest learners.

Now is the right time to plan a messaging campaign to parents, guardians, and caregivers to let them know how critical good attendance is to the success of their children, especially in the early years when children are building a foundation for learning to read proficiently.

As we begin the new school year, we should raise the awareness of parents, guardians, and caregivers of the effects of chronic absenteeism and truancy. An excellent toolkit for an effective messaging campaign with sample back to school letters and other resources is available on the Attendance Works Strategy 2: Use Effective Messaging web page at https://www.attendanceworks.org/resources/toolkits/teaching-attendance-2-0/create-a-welcoming-environment-that-engages-students-and-families/strategy-2-use-effective-messaging/.

Reducing chronic absenteeism rates also requires a multi-tiered approach supported by your supervisor of attendance, and a collaborative school attendance review board (SARB) process. If you already have low chronic absenteeism rates and a strong multi-tiered system of attendance support that promotes good attendance and early and intensive interventions, I urge you to consider mentoring other districts through the Model SARB Recognition Program.

The 2019–20 Model SARB Recognition Program, which is sponsored by the California Department of Education (CDE) in cooperation with the California Association of Supervisors of Child Welfare and Attendance, has an Intent to Apply with a deadline of October 4, 2019. The Intent to Apply, Instructions, Application, and Application Certification Form are available on the CDE Model SARB Recognition Program web page at https://www.cde.ca.gov/ls/ai/sb/modelrecognition.asp. Applications will be due to the CDE on February 7, 2020, by close of business at 5:00 p.m. (PDT).

Outstanding and innovative programs chosen for the award will serve as models for other local or county SARBs in the state that are using a multi-tiered system of support to reduce chronic absenteeism rates and increase graduation rates. Again, I encourage those that have already developed model programs to serve as mentors to others.



It is unimaginable to focus on the efforts of the Los Angeles County Office of Education. To put their daily challenges into perspective, please reflect on the following facts:

- The geographic area of Los Angeles County is 4,751 square miles. That is 1752 square miles larger than the square miles of Delaware and Rhode Island combined!
- There are 1,567,782 public education students in Los Angeles County.
- There are more public education students in Los Angeles County than people in any of the following states: Hawaii, New Hampshire, Maine, Rhode Island, Montana, Delaware, South Dakota, North Dakota, Alaska, Vermont or Wyoming.
- There are eighty school districts in Los Angeles County.
- In the United States, only the New York City School District has more students than the Los Angeles Unified School District.

The Los Angeles County Office of education continues to provide leadership throughout the entire county. They provide essential services and their staff contain many of the country's most dedicated educators. In many ways, the history of CASCWA parallels the history of the Los Angeles County Office of Education.

State SARB Member, County SARB Chairperson, ACSA Region 14 Council for Student Services and Special Education (We put on the annual Every Child Counts! Symposium through ACSA - held in Monterey, Anaheim, and Palm Desert for 2020.)

What are the primary functions and responsibilities of your division/department?

The SSS Division has several units: Community Schools (Hub for Services on school sites), Friday Night Live (Anti-drug, tobacco, and alcohol prevention programs work with students) in collaboration with Comprehensive Prevention Services, Expanded Learning Technical Assistance (Before and After School Programs and Summer Programs), Foster Youth Services Coordinating Programs (Meeting the needs of youth in foster care or on probation), Community Health & Safe Schools (Health outreach, mental and physical health issues, 504 plans, suicide prevention, counseling, and PBIS instruction), and our unit - Child Welfare and Attendance (Homeless youth services and

supports, discipline, enrollment and attendance, plus expulsion and interdistrict permit appeals).

What are your division/department goals - short term/long term?

CWA seeks to support districts and families to fairly address issues while keeping students safely in school. We also provide appropriate advisements for due process in collecting records and administering discipline in a positive and progressive manner. Our unit is responsible for advocating best practices, policies, and legislation to ensure high quality student programs; improving collaboration and communication between general education, student services, special education, and other support agencies and organizations; facilitating the development and understanding of current trends and financial issues related to their impact on student programs and services; planning and coordinating timely and meaningful professional development offerings for new and experienced school administrators. The unit title of Child Welfare and Attendance has supporting roles played by our colleagues who perform data analysis, clerical and data entry support, coordination and workshop presentation, social work advisements, and administrative guidance for families and districts. We also refer to the Charter Organizations, districts, and the CDE when complaints need to be addressed.



Please describe how your division/department interacts with others (individuals, districts, LACOE and/or CDE.)

Individual parents and students are welcome to consult regarding what are safeguards in place and how they are protected by the California Education Codes and other laws when it comes to homeless youth, K-12 student discipline and attendance. We are of assistance to families and to our 80 local districts. Although there are specialized units that work with Charter Schools, we also receive calls regarding best practices to meet the student needs in those unique public settings.

CWA provides specific direction to liaisons for homeless education needs and enrollment in an efficient manner to avoid unnecessary stressors in an already stressful living situation. Homeless and Foster units work closely together to meet the needs of the community resources and guide the local districts to follow codes and regulations for a safe school experience. We have multiple publications as educator guides to homeless, attendance, discipline, records, enrollment, and annual legislative updates.

My responsibility is to create the Annual Notification for Parents that all districts may use according to federal and state law requirements. I utilize the legislative update to amend the notifications and provide a necessary resource that may be used across the state at districts and charter schools.

Our County SARB is advised by the State SARB, through the CDE State chairperson and board, to provide a comprehensive Local SARB that can monitor, collect data, prevent, intervene, and provide supports to students and families who need to return to regular attendance - every day and on time. Our interdistrict appeals from parents seeking to attend outside their resident districts exceeded 1600 files processed for last year alone. We are well past 800 this school year and continue to provide coordination of hearings and guidance through the interdistrict appeal process from documentation, fact-finding and research, to presentations before the LA County Board of Education for final decisions. We also manage the expulsion appeals that bring forward parent's claims of inappropriate process at the local levels to present findings and guide to the board meeting final decisions, as well.

What are a few of your goals (short term or long term?)

My work with families and districts is guided by my experience as a parent, teacher, IEP coach, and administrator. I can empathize with the parents and relate to their frustrations that I fully understand as a parent, while giving them the needed resources by directing them to the appropriate organizations or person who will best assist in their unique situation. As an educator, I expect that the adults in charge of children are behaving in the best interest of their students while obeying the laws in a compassionate manner. I strive to provide a helpful and welcoming invitation through discussions on how we may evolve and improve our methods of student supports.

up to date training and certification for SARB Chairs and Board Members. In an effort to accommodate our very large county, I have started to offer livestream workshops to reduce travel time and increase learning time for our participants. Our Online SARB Certification Renewal is the first in the state offered to maintain the focus on early identification, interventions, and referrals through the SARB process. I will assist in the workshops regarding Residency, Custody, and Enrollment, along with our Records and Discipline workshops. Our unit hosts quarterly Area Meetings for the local CWA Directors to attend and stay abreast of current research, resources, and guidance.

I have been certified in Mental Health First Aid and have started instruction at our local districts with the DPSS counselors. I am working with our LACOE Safety Committee to provide a safe and sane working environment and will be soon trained in CERT for Downey Community Emergency Teams. Later this fall, I plan to attend Restorative Practices training with a team comprised of Community Health and Safe Schools and CWA units in collaboration. I hope to share this method or restoration to the local SARB chairs, as a means to provide positive supports and to build school communities. My special education administration experience helps to manage the unique needs of that population when looking at all the student support domains. I may sometimes assist in other unit workshops when they want to address special education or attendance issues in their presentation.

The workshops that I offer include attendance focus: SARB Chairpersons Bi-Annual Meetings, State SARB Quarterly Videoconferences, Model SARB writing, grading, and recognition at the CDE Event, followed by our local LA County Model SARB Symposium. We share the highlights from each of our Model SARB recipients and honor the students who are awarded attendance improvement at this event. It is a celebration in positive attendance supports and success stories. As County SARB Chair I strive to certify and maintain

I am a member of CASCWA, CAPPA, ACSA, ALACOSA, and PTSA - all focused on the well-being and support of students. I participate on two councils and hope that I can give back to the organizations that provide so much. I present sessions at events and welcome partnership in presentations. In addition, I hope to increase the workshops or advisements that I provide to our local organizations. Department of Public Social Services, Department of Child and Family Services, and Deputy District Attorneys and Probation Services are a few outreach presentations that I have provided. I hope to grow that cross-training between County service organizations.

LEGISLATIVE UPDATE September 2019

Listed below is a brief synopsis of current legislation that has been introduced and with minor or no opposition. Please note that each bill listed has received legislative approval out of either the state Senate or Assembly by the legislative deadline of May 31 in order to continue the legislative process. ASSEMBLY BILLS

AB 8(Chu) -Will require on or before December 31,2024, all schools, county office of education programs and charter schools to have at least one mental health professional for every 600 students accessible to pupils on campus during school hours.

AB 16 (Rivas)-Requires all schools to report the number of homeless students to the state and require any intake form used to identify homeless students to include a statement that the child will not be taken away from their family because the family is experiencing homelessness.

AB 34(Ramos)-Commencing with the 2020-2021 school year, require each school district to post in a prominent section on the district web site policies and procedures involving bullying and bullying prevention.-SIGNED BY THE GOVERNOR.

AB 197 (Weber)-Requires commencing with the 2022-23 school year that all districts and charter schools offering a kindergarten program implement at least one full-day kindergarten program.

AB 272 (Muratsuchi)-Explicitly authorizes a school district, county office of education and charter school to adopt a policy to limit or prohibit the use by its pupils of smartphones while the pupils are at a school site.- **SIGNED BY THE GOVERNOR**.

AB 493 (Gloria)-Commencing with the 2021-2022 school year, each school district, county office of education and charter school to provide online training at least once every two years to teachers in grades 7-12 and all other certificated employees of on school site resources and support of LGBTQ pupils and strategies to support this student population.

AB 901 (Gipson) - repeals the authority of a juvenile court to judge a student between ages of 12 to 17 as a ward of the juvenile court based upon truancy.

AB 1354 (Gipson)-Requires the county office of education to assign transition oversight responsibilities to the existing county office of education personnel to ensure pupils to have complete and accurate education records when a pupil enters the juvenile court school.

SENATE BILLS

SB 138(Roth)-Requires all schools beginning January 1, 2021 to make juvenile diabetes informational materials available to all new enrollees and pupils in grade 7.

SB 217 (Portantino)-Requires for the 2019-2020 school year and every school year thereafter, a charter school or school district to admit a child to a transitional kindergarten program who will have their 5th birthday after December 2 but during that same school year if the child is an individual with exceptional needs subject to specified conditions.

SB 276 (Pan)-Will require the Department of Public Health to review immunization reports from schools with less than overall immunization rates of 95 percent and physicians and surgeons who submitted five or more medical exemptions in one year and render a decision which may invalidate the exemptions signed by a physician or surgeon.

SB 316 (Rubio)-Requires all public schools that issue ID cards in grades 6-12 beginning July 1,2020 to include the telephone number of the National Domestic Violence Hotline on the back of the ID card.

SB 419(Skinner)-Prohibits all public schools including charter schools from suspending a student from school for will defiance from grades TK-8 beginning July 1,2020.

SB 541(Bates)- Requires every public, private and charter school to conduct a lockdown drill at least once per school year and for every charter school to include the procedures in their petition.

SB 443 (Rubio) deletes the requirement that students who enter transitional kindergarten who have birthdays after December 2 from generating ADA until they reach age 5.






KOPPEERUD MESSAGE TO STATE SARB

As you know, the California Association of Supervisors of Child Welfare and Attendance (CASCWA) is a long-standing partner with the California Department of Education (CDE) in sponsoring the Model SARB Recognition Program.

At CASCWA's State Executive Meeting yesterday, I was excited by our discussion of the Model SARB visitation process and other items related to the Model SARB recognition and the CASCWA State Conference.

We reviewed how an **Intent to Submit** for the Model SARB Recognition Program will be used to prepare for the Model SARB readings and the Model SARB visits, and how we will need to inform potential applicants that the **Intent to Submit** will be due on **October 4, 2019**. The 2019-20 Model SARB applications will be due on **February 7, 2020, by 4:00 p.m.**

Frank Boehler, Jeni Mendel, and Rick Riegel from the 2020 CASCWA State Conference Committee discussed how they intend to present the Model SARB Recognition Program at this year's State Conference to enhance interaction with the 2020 Model SARB recipients.

CASCWA has big goals for the Model SARB Recognition Program and the State Conference in San Diego. CASCWA plans to set a standard for all school districts and county offices in attendance practices that reduce chronic absenteeism and improve graduation rates. The CASCWA Web site will enable members to quickly link to important documents and tools that they can use in their daily activities.

The CASCWA Executive Board also discussed creating a PowerPoint for the State Conference that will show-case each of the Model SARBs with short comments and photos.

These topics and other exciting plans for the Model SARB Recognition Program and the CASCWA State Conference were discussed at ourState SARB meeting on August 15.
